4.1 Description of first aid measures

General advice Inhalation	Show this safety data sheet to the doctor in attendance. Move to fresh air in case of accidental inhalation of dust. Keep patient warm. Evacuate personnel to safe areas. Do not breathe vapors or spray mist. Wear a positive-pressure supplied-air respirator, flame retardant antistatic protective clothing. Shut off leaks if without risk. Keep people away from and upwind of spill/leak.
